## 60\% Tax Trap

## Here's how it works

If you earn $£ 100,000$ or more, the rate of Income Tax you pay will be impacted by the gradual removal of the £12,570 personal allowance (the amount of income you can earn each year without paying Income Tax). It's currently tapered away at a rate of $£ 1$ for every $£ 2$ you earn above £100,000.

Here's an example. Let's say your salary has increased from £100k to £110k.

Here's how the extra £10k would be taxed:

## Did you know...

It's often thought that the highest UK tax rate is $45 \%$ but that's not the case. If you earn more than $£ 100,000$ per year, you could be taxed at a rate of $60 \%$ on income between £100,000 and £125,140.

## £4000

This is the standard 40\% Income Tax for a higher rate taxpayer.

## £2000

This is the additional Income Tax as the personal allowance is reduced by $£ 5,000$.

## £6000

Total Income Tax paid. That's $60 \%$ of the pay rise you received.

Three things to consider:

Making pension contributions on any excess income you earn over £100,000 can effectively prevent your taxable income from going above the £100,000 threshold and into the $60 \%$ tax trap.


Pension contributions also benefit from tax relief at your marginal rate.


Making donations to a qualifying charity can also reduce taxable income in the same way as making pension contributions.
